AQHA members have the opportunity to request color testing on their horse. The basic coat colors, such as, chestnut/sorrel, bay/brown and black are controlled by an interaction between the genes.

In many cases, a horse's coat color can be determined based off its physical appearance. However, genetic testing may be necessary to make the right decision.

The coat color panel is the most comprehensive color test offered by the AQHA and includes 13 tests, excluding the roan zygosity and gray copy test. When only a specific gene needs to be tested for, any of the tests can be ordered individually.
