A frozen embryo permit is required to register any foal that is produced from an embryo that is frozen and stored with the intention of implantation at a later date.

- The owner of the permit at the time the registration application is submitted to AQHA will be recognized as the breeder and owner of the resulting foal in all instances.
- The breeding dates listed below must correspond to breeding dates that are submitted to AQHA on a stallion breeding report for that year.

CAUTION:

- If a permit is NOT purchased, the original breeding dates will no longer be recognized for registration purposes by AQHA. Instead, the year the
 embryo was implanted will be considered the breeding year, and applicable documents will be required from the then owner(s) of the stallion
 and mare.
- As the mare owner, I must ensure that a sufficient number of Frozen Embryo Permits are purchased prior to my sale of the mare. I also understand that if the mare was born on or after 1/1/2015, her stored embryos may not be used beyond two years following her death.

I hereby acknowledge that I have read and agree to be bound by and follow the AQHA rules pertaining to frozen embryos. I also understand that AQHA will investigate non-compliance with these rules, and in the event of such non-compliance, any resulting foals may be ineligible for registration.
